**Hauv Chaw txiav Plaub – Them Nqi Zog Rau Tus Neeg Nres Plaub**

State Public Defender yeej yuav tsum ntsuas tias tus tub hais plaub tej nqi zog ua num rau cov neeg laus yog npaum li cas. Cov nyiaj luag sau tau yog tej nyiaj sau se uas luag yuav siv ntiav neeg ua num rau lub koom-haum ntawd ntag. Txawm tias feem coob cov neeg uas tau txais kev pab los ntawm State Public Defender yeej yog neeg tsis muaj nyiaj txiag li, tiamsis muaj ntau leej tseem muaj peevxwm rov them nyiaj tuaj txhaws tej nujnqis uas luag twb pab hais nws rooj plaub uas yog tau siv tej nyiaj sau se lawm thiab.

Tej nyiaj ua nqi zog no yog nomtswv qib siab tau teev tseg cia rau tej hom plaub lawm. Tus nqi zog yog nyob raws li lub sijhawm hais rooj plaub uas ib rooj tsis xws ib rooj; luag tsis tau muab xam them raws sijhawm ib teev dhau ib teev raws ib rooj rooj plaub mus rau lwm rooj. Txhua rooj plaub nyias muaj nyias ib hom hais, yog li luag thiaj teeb tus nqi dagzog qhov siab kawg los rau qhov qis kawg tseg cia lawm. Thaum pib yuav hais nws rooj plaub, luag yuav muab ib cov hnab ntawv rau tus neeg raug plaub kom npaj ntim nyiaj rau, qhia hais tias nws tso nyiaj npaum li cas xa tuaj them.

Yog tias yus muab siab them tej nqi raws li teev tseg li ntawm 60 hnuv, yus yuav txaus siab heev vim yus pom hais tias yus htem tus nqi tsawg tshaj qhov yus yuav tsum them lawm tiag. Pivtxwv li no, tus nqi luag teev tseg rau tej plaub me luag tsuas kom them ib hlis \$60 xwb, yog tias yus ua ib zaug them kiag tus nqi yuav tsum them twb yog \$240 lawm.

Cov neeg raug plaub uas yeej tsis muaj peevxwm yuav them hlo li yuav tau sau daim ntawv qhia txog nws li nyiaj txiag qhia rau luag kom luag htiaj li muab cov nuj nqis no txo.
